Education Investment Payment Policy

School fees and tuition are essential for the continued operation of Immanuel Lutheran School. When registering your child (ren) you are asked to choose a payment plan which meets your budget needs and is most convenient. Unless a financial hardship arises, all monies are to be paid according to one of the three options. The Principal or Pastor should be notified in writing of any financial hardships.

Payment of fees for the 2010-2011 school year will be by: (PLEASE SELECT ONE)

- OPTION 1** Single payment due on or before July 1 with a \$50 discount per family (Full-Day Student Only!).
- OPTION 2** Two payments, half due before July 1 and the balance before December 1.
- OPTION 3** F.A.C.T.S. monthly payment plan. Payments budgeted over 10 months beginning in July. Payments can be made either on the 5th or 20th of the month. See brochure for additional information. If you choose to pay monthly through this plan, you must complete the F.A.C.T.S. Automatic Tuition Payment Agreement form. If you used F.A.C.T.S. last year, a preprinted agreement is available in the school office.

PLEASE NOTE: In order for the office to complete the registration, all pages *must* be completed and returned to the school along with the \$100 registration fee per family. After April 30, the registration fee will be \$130. This fee is refundable only if the child cannot be accommodated by the school. **If option 1 or 2 is selected and payment is not made by the due date, then payment will have to be made through the F.A.C.T.S. plan.** If you have any questions, please contact the school office at 781-4135.
